A CELEBRATED NETWORK OF THE BEST GOLF

JUPITER, FLORIDA: From 1998 to 2007 an incredible amount of private golf clubs were built. It's the contention of AppleTree Management Group that 95 percent of the very best golf in existence was built during this time and that many of these courses are undiscovered and underutilized.

These courses truly created a golf course renaissance and AppleTree Management is organizing a residential network with these new undiscovered private golf clubs along with well-known famous golf resorts.

Many of these new private clubs want ultra high-end "blood flow" and need a constant mechanic for lead generation in addition to the purchasing of memberships and real estate that AppleTree societies will provide.

Through these designs so many new places have now become some of the most desirable retreats in North

America. Venues that have always had sheer beauty, and were fishing, beach, or ski destinations, now have become true contenders for one's second or extra home as well as a retirement consideration because of the incredible golf that now exists.

Imagine a total reciprocal network of residences that will have a projected 30 destinations and access to over 20 "rank worthy" private golf clubs and 10 well-known resorts in second home and vacation home markets.

## 13 APPLETREE REGIONAL SOCIETIES

*Customized selection of properties based on where you live:* Each region of the country has favorite destinations and travel patterns. AppleTree members will have customized properties and associated private and resort golf. All 13

Appletree members are scheduled to have residences in both Big Sky, Montana, and Jackson Hole, Wyoming, separated by a three and one-half hour drive through Yellowstone National Park.

NATHANIEL CROSBY, son of famous crooner Bing Crosby, was destined to make his mark in the golf industry. He managed the Crosby Pro-Am for eight years and is the founder of AppleTree Golf Society.

Regional Societies are organized in geographic regions where member prospects live and like to travel.

## ITS ALL ABOUT ACCESS

*96 member societies accessing 40 multimillion-dollar properties:* The 13 Regional Societies are by design—96 member regional networks with 40 properties that are at or near \$2.5 million dollars each. Many of these properties will be with associated private and resort golf access. With so many properties for so few members, they would be able to use the network with the same frequency that they might if they had their own property in each location.

## EXCLUSIVITY IS ABOUT MATH

*A peer-to-peer invitation:* AppleTree Societies will organize the launch of the 13 separate societies this year with the organization of 32 "founder members" region to region. Each society will be organized by hand selected founder members. The founder members will, in turn, invite the 64-member balance of each society by pro-

posing two member prospects each over a 24-month period, forming a true "peer-to-peer" invitational travel group and an exclusive invitation.

## A PERMANENT ASSOCIATION

*Developing life-long friends:* The ultra affluent can certainly afford the purchasing and maintaining of a network of properties as well as a collection of private golf clubs; however, in many cases the expanded network results in underutilization of most of the properties. One may find themselves with a mirage of acquaintances instead of a collection of "life-long friends."

A regional travel society literally introduces members who likely have the same type of professional success, also share in the love of golf and travel, and live in close proximity to each other. These new friendships will likely thrive and flourish amidst different backdrops, as members will enjoy distinctive and separate memories at some of North America's most stunning vacation destinations. ►

*UNDERUTILIZATION OF "EXTRA HOMES"*

*Hands-free, management-free vacations:* Many are fortunate to be able to afford the flexibility of multiple residences, but it can become an annoying event when they discover over time that they are using their properties less than three weeks annually.
